

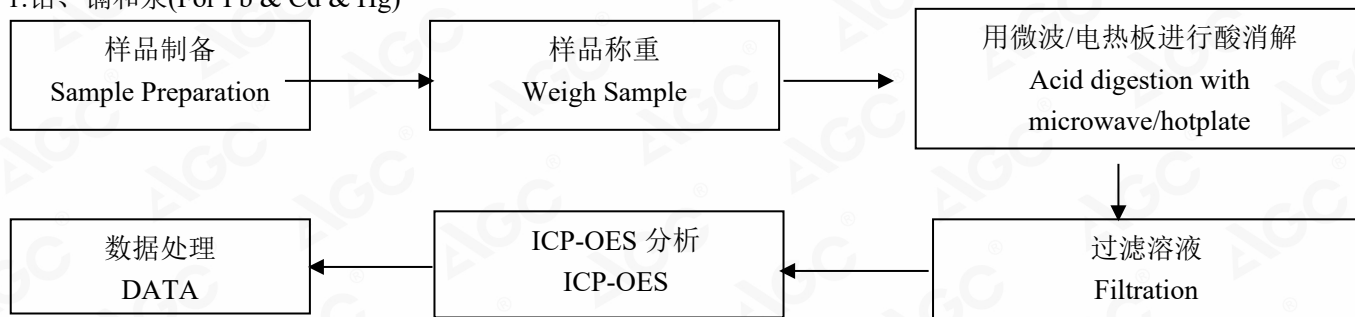

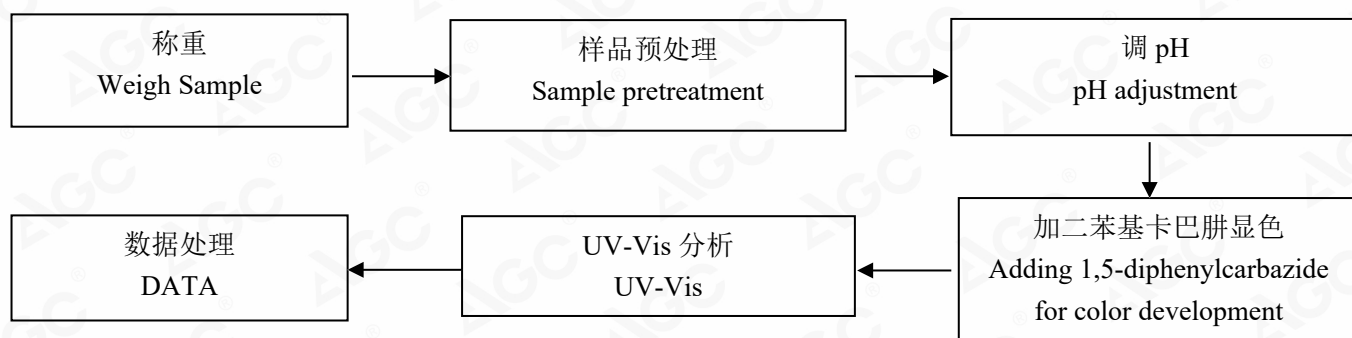

2. 六价铬 (For Cr(VI))

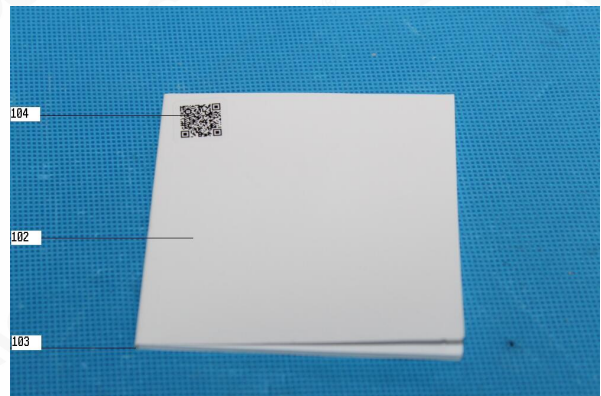
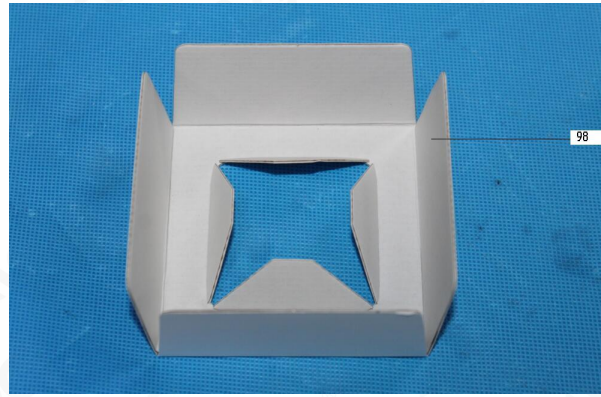
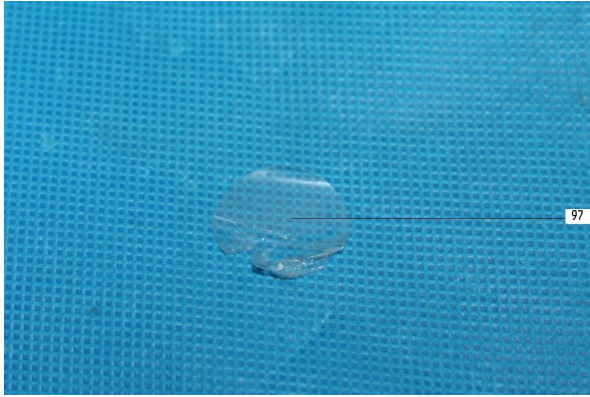
