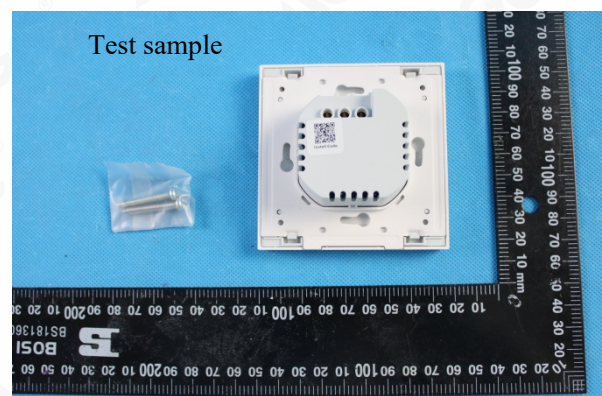
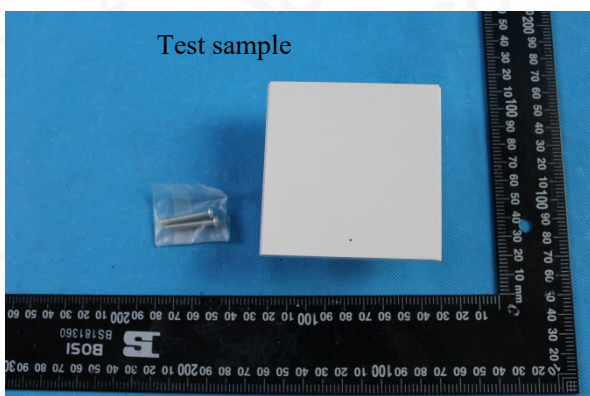
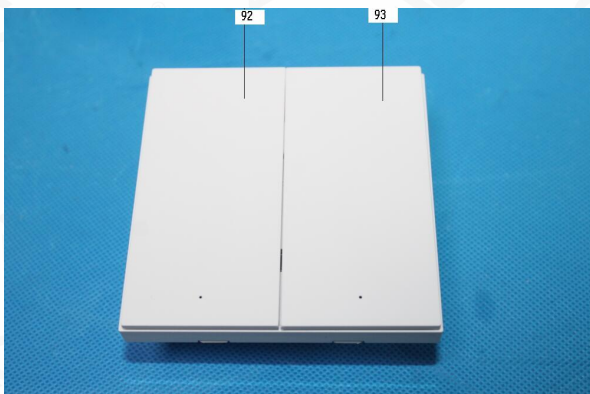
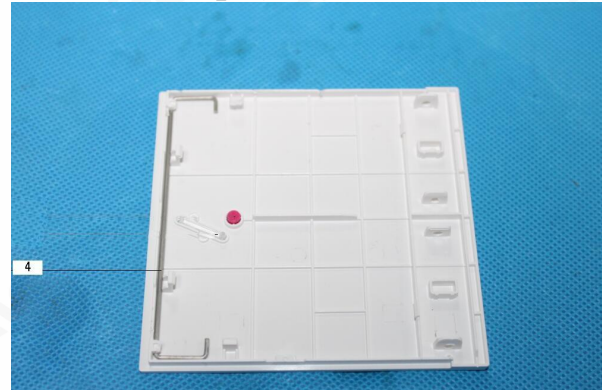
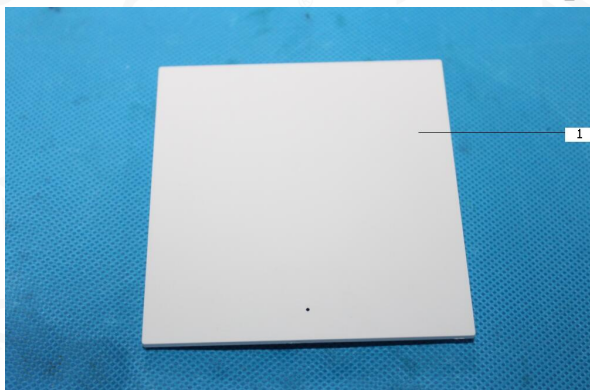




### 测试流程图 (Test Flow Chart)



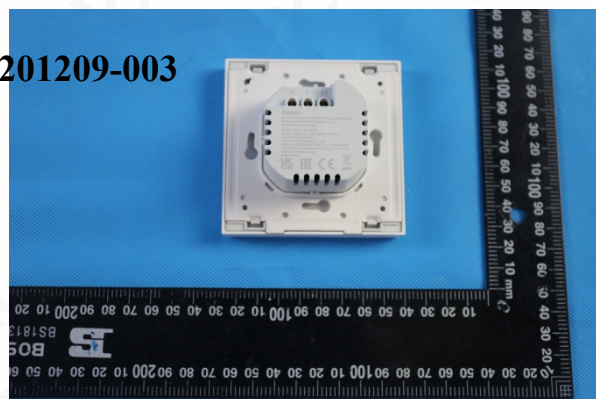
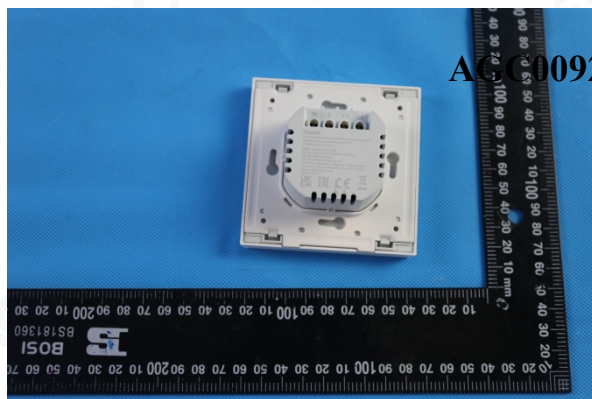
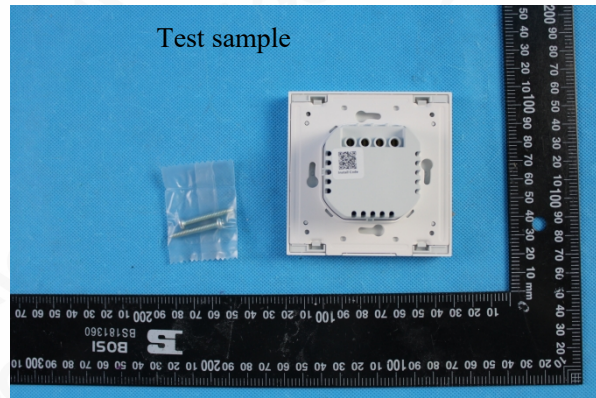
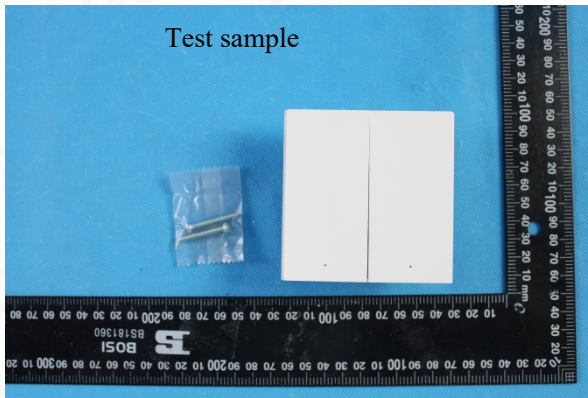
