# 3. TEST RESULT

The maximum output power of Bluetooth (BR&EDR) is <u>1.10dBm (1.29mW which is less than 20mW)</u>. Please refer to ETSI EN 300 328 (V2.2.2) Test report (AGC14435230901ER02) for the result of Maximum Transmit Power, which deemed to comply with the basic restrictions without testing.

The maximum output power of Bluetooth (BLE GFSK 1Mbps) is 1.39dBm (1.38mW which is less than

**20mW).** The maximum output power of Bluetooth (BLE GFSK 2Mbps) is **1.12dBm (1.29mW which is less than 20mW).** Please refer to ETSI EN 300 328 (V2.2.2) Test report (AGC14435230901ER03) for the result of Maximum Transmit Power, which deemed to comply with the basic restrictions without testing.
