WARNING

CONNECTION

- Turn down the volume of your music player before connecting it with Spiro.
- Connect the 3.5mm jack of Spiro to your stereo music player for Input.
- Check the L & R marking on your earphone to experience actual effect. "L" and "R" marking represents "Left ear" and "Right ear" respectively.

MIC & CALL BUTTON

Cable is equipped with Integrated Microphone & Call button:

- Press the button once to answer the incoming call.
- Press the button again to end the call.
