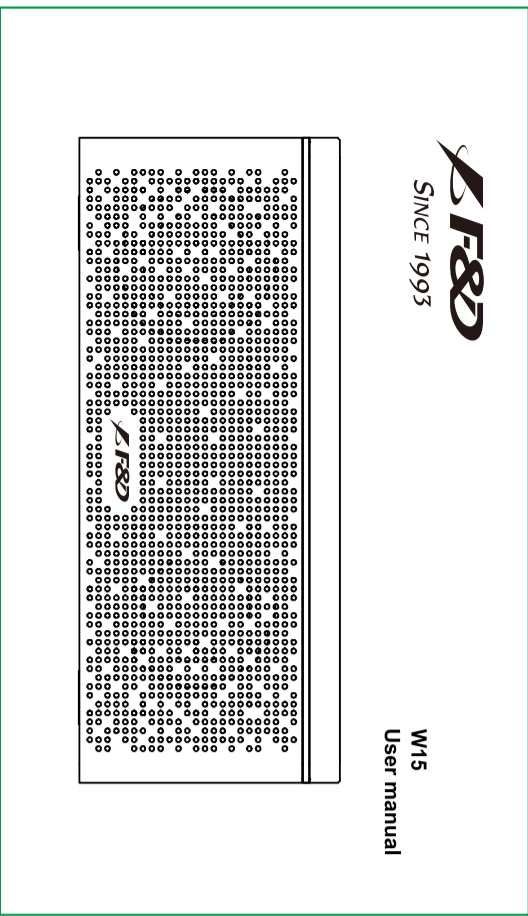

BUTTON CONTROLS

⏻ Standby:
Long press to Turn ON and Turn OFF the unit

⏪ Volume decrease:

- Short press to decrease the volume
- Under Bluetooth and TF card mode, Long Press to enter previous song

⏸ Pairing, Play/Pause, Calling:

- Under Bluetooth mode(without AUX IN and TF card in W15), long press entering pairing mode
- Under TF card mode, The LED light flashes slowly, The LED light will always light up after pausing music
- Under Bluetooth and TF card mode, short press to pause/play music
- Under Bluetooth mode, short press to answer the call and long press to reject the call

⏩ Volume increase:

- Short press to increase the volume
- Under Bluetooth and TF card mode, Long Press to enter next song

⊗ source:
Press to switch among audio sources: Bluetooth (Blue LED lights up), AUX (Red LED lights up) and TF card mode

Bluetooth mode

- Turn on the unit, W15 will automatically search the Bluetooth device. If the device paired before, W15 will connect automatically. If can't find paired device, W15 will enter pairing mode automatically.
- Active "Bluetooth" function on your device and search for "Fenda W15".
- Enter "0000" if your device asks for the PIN code.

- Using the supplied USB cable to connect the MicroUSB jack, and another terminal connect with USB power like PC or other universal USB power.
